RE: OLD TOWN POCATELLO LIGHTING & STREETSCAPE PROJECT UPDATE

Please accept this as an update on the first phase of the Old Town Lighting and Streetscape project and a request for Project Billing #1 (see attached Schedule of Values).

- The project construction started on Monday, April 21, 1997, at the corner of W. Whitman and S. Main Streets.
- To date, conduit for the new lighting system has been laid on both sides of the 200 and 300 blocks of S. Main St.
- Existing light poles on S. Main is scheduled for demolition to begin on Wednesday, May 7th.
- A-Core has been busy saw cutting along most of Main Street and should begin cutting new pole sites within the next two weeks.
- Terry Dance, owner of the Station Square building, has agreed to replace his entire sidewalk, and construction should begin on Thursday, May 8.
- A change order exists to order four (4) additional tree grates that engineering overlooked during the bidding process.

This project is running very smoothly and with little incidence. Property owners are somewhat uncomfortable when their Main Street parking has been affected, but remain very positive that the project is worth some discomfort in the long run.

Warbonnet will provide a monthly statement like the one attached, as well as a project update by the first of the month so we can distribute the information to you in a timely manner.

Here is a brief update of the progress we have made on the a-fore mentioned project.

Items Complete:

- A. Contracts Signed.
- B. Bond Placed.
- C. Subcontracts Signed.
- D. Pre-Construction Walk-thru Complete.
- E. Purchase Orders placed for:
 - 1. Lights & Bollards.
 - 2. Trees.
 - 3. Tree grades.
 - 4. Sidewalk drains.
 - 5. Electrical Panels & Misc. Materials.
- F. Dig-line survey of Main Street (Whitman to Wyeth).
- G. City Electrical Permit placed.
- H. Vendor Data Approved.
- I. Install Power Service in Whitman alley.
- J. Bore and install conduit from service to Main Street.
- K. Flat Saw or bore on Main Street for conduit installation complete from Whitman to Lewis Street.
- L. Receipt and storage of Trees.
- M. Receipt of Sidewalk drains.

Items Currently under way:

Receipt of Tree grades (Partial).

- B. Receipt of Electrical Materials (Partial).
- C. Dig-line survey of Main Street from Lewis Street to Wyeth Street.
- D. Flat Saw and Bore for conduit installation along Main Street, from Lewis Street to Wyeth Street.

Future Items:

- A. Idaho Power to remove power feeders for steel poles on Main Street between Benton Steel and Bonneville Street.
- B. Remove steel poles and deliver to City laydown area.
- C. Begin removal of sidewalks, curbs and gutter on Main Street from Whitman Street to Lewis Street.

After the walk thru with Mr. Turner (city engineering), Mr. Ankrum (civil subtier), Mr. Walling (WBE electrician) and Dig-line, installation of the decorative light pole located on Northwest corner of Main Street and Lewis Street will be difficult because of the US West fiberoptics under the sidewalk. We feel the best option is to delete this installation and surplus the pole to storage. We have some other concerns that we need to address. I would like to request an informal progress meeting to discuss the cosmetics of the sidewalk, asphalt that has been overlaid on the gutter and how the new sidewalk will match up to the existing sidewalk. We are proceeding with the original scope of the project as required by the contract documents. We hope you are successful with the city office to improve the damaged and deteriorating sidewalk, curb and gutter that in not included in this project. We feel we could do all concrete changes at 15 % over the square and linear foot prices on the contract documents if we can do this work concurrent with the original scope. Fred Meyer TIF Request

At the April PDA meeting, a representative of the Fred Meyer Corporation requested the use of TIF funding for their new super store complex. A specific request was made for relocation costs for some of the existing businesses that occupy space on the current site.

After reviewing the PDA "Guidelines for Tax Increment Financing Projects," the following criteria may clarify the use of TIF revenue as it relates to relocation costs.

Item #1:

Funds from TIF projects will be used primarily to pay for publicly-owned improvements and for infrastructure to serve private sector development projects. . the overall goal is to create projects whereby the public benefit is primary and exceeds the private benefit. The public benefit must be specific and identifiable as opposed to the private benefit.

Guidelines which apply:

- Protect, to the greatest extent possible, the tax base in the Urban Renewal
 Area for the needs of the taxing entities.
- TIF should not become a panacea for every financial need -- be cautious and selective.
- Do not use TIF when private development will happen of its own volition and can happen of its own volition.
- Do not use TIF for any non-physical improvements or sources such as rent subsidies.

Memorandum to PDA Members Page Two May 8, 1997

Item #2:

Guidelines which apply:

- Use only the minimum amount of TIF funds to fill in any project financing gaps.
- Use only when and if <u>all</u> other financing mechanisms fail.
- Use the largest percentage of financing that is possible from private sources.

Item #3: As TIF uses public tax dollars, each candidate TIF project should be evaluated with full recognition of the strong demand on property tax revenues and the limited supply of those funds. Therefore, only that TIF money as determined to be absolutely necessary for the success of the project should be allocated. . .

Item #4:

Guideline which applies:

• Stick to the purposes of the Urban Renewal Acts. Connect each project to the stated objectives in the enabling legislation. TIF should be targeted to need that is expressed in the enabling legislation.

SUBJECT: Fred Meyers Expansion

The following are results of phone contacts with other citys where Fred Meyers has super stores:

Meridian - (888-4433 Dean Elert)

Fred Meyers was a new business to the city completed in 1995, on Fairview Road; site was vacant

the city does not have a development authority; no request was for assistance was made

Twin Falls (736-2240 Dave MacAlindin)

- Fred Meyer was not in the city before the super store was constructed. The store is 173,000 square feet which is similar size to the proposed Pocatello store; involves approximately 200 jobs
- the Blue Lakes Mall was demolished which involved extra expense to cover a canal;
- Fred Meyer did not request any financial assistance (TIF policy is to assist primary jobs only, retail would not have been considered)
- the location is not eligible for urban renewal consideration
- Side note they have used tax increment capture from one industrial area to use in the downtown area (\$4.5 million bond for downtown improvements)

Idaho Falls (529-1276 Renaee McGee)

- Fred Meyers made no request for financial assistance
- construction was completed in 1996 at the north end of Yellowstone Highway and involved the demolish of the old Sears store that had stood empty since 1985
- store size is approx 150,000 sq ft; 5 or 6 other mid-size stores also made location there
