POCATELLO DEVELOPMENT AUTHORITY BOARD OF DIRECTORS

The Idaho Urban Renewal Law of 1965 authorizes the Mayor, with advice and consent of the City Council to appoint a board of commissioners for an urban renewal agency to function within the municipality, provided that the Council has first passed a resolution finding that one or more such areas is necessary, and that there is a need for an urban renewal agency to function in the city. Pocatello's urban renewal agency was found necessary by Resolution #1988-13 and the PDA board members were appointed thereafter. Unlike other advisory boards, state law declares this agency to be "an independent public body corporate and politic" and gives it a wide range of authority to effectuate urban renewal.

The Board shall consist of no less than 3 members and no more than 9 and all members serve four-year terms, which expire May 1st. They meet the second Tuesday of every month at 11:00 AM at the Municipal Building, 911 N. 7th.
