



# **GENERAL PROJECT SCOPE**

The Halliday Street Storm Water Improvement project was planned and designed to reduce the potential for flooding in the heart of the city. It consists of construction of approximately 10,000 feet of concrete pipe from Halliday Street at the Portneuf River to the intersection of 19<sup>th</sup> and Center Streets. It also involves constructing an outfall for discharge into the Portneuf River, new catch basins and laterals, Union Pacific Railroad crossing in the abandoned Halliday Street underpass, and street reconstruction, including new ADA pedestrian ramps at many intersections. A discussion of major work segments completed for this report period follows.

# **WORK PROGRESS AND SCHEDULE**

### Headgate Structure and Portneuf River Outfall

The bottom half of the headgate structure is in place. The storm drain pipe from the headgate structure to the Portneuf River has been set and the Portneuf Channel wall has been reconstructed. The headgate structure and all work near the Portneuf River is scheduled to be completed in August 2001.

#### Storm Drain Pipe

Approximately 700 linear feet of storm drain pipe was installed and backfilled during this period. A total of 900 feet of storm drain pipe have been installed since the beginning of the project. Due to complications with the railroad, completion may extend into 2002. The Contractor plans on using two crews. The second crew is not yet on site. The mainline pipe installation for this period is shown on the attached Project Map. Pipe installations from the previous period as well as expected mainline pipe installation for the next period are also shown.

#### Water Pipe Reconstruction

The 14 inch waterline at Arthur Avenue was reconstructed through the intersection at Halliday Street. This was an arduous task since the existing line was shallow and laid on boulders.

#### **Sewer Pipe Reconstruction**

Reconstruction was performed on West Halliday at the alley between South Arthur and South Main. This involved the replacement of approximately 40 linear feet of clay pipe with new PVC pipe. The new sewer line on Whitman Street, originally planned for July construction was delayed and now scheduled for August as shown on the attached Progress Map.

#### Catch Basins and Laterals

One catch basin with lateral pipe was constructed. This work is typically accomplished prior to backfilling the mainline pipe.

#### Asphalt paving

No asphalt paving has been performed during this period. Paving is scheduled to be completed from Main Street west to Garfield approximately August 10.

### Railroad Right of Way Work

During this period approximately ¼ of the material in the abandoned underpass was removed. The metal deck plate on the west side of the Railroad Right of Way was installed. Work has been delayed because 60 feet of the old underpass deck were found to be missing approximately 100 feet from the east side of the underpass. This 60 foot zone supports three sets of railroad tracks used for storage. Greg Lanning, the City Director of Public Works, is leading an effort to gain permission to remove these tracks (temporarily), install the pipe through the 60 foot zone, backfill, then reconstruct the tracks. The alternative would to be either bore or jack pipe which would cost the project an additional \$300,000 to \$500,000. The railroad appears to be cooperative. The decision from the railroad is expected mid-August.

#### **Concrete Flatwork**

Approximately 250 linear feet of curb and gutter was placed during this period. One vehicle approach was also replaced. Concrete flatwork is typically placed after the piping is completed and before the street is paved.
